MUSTANG BY SALEEN

Looking for a new but different Mustang? The Saleen Mustang might be just right for you. Steve Saleen, working under the name of Saleen Auto-

sport (313 N. Lake Street, Burbank, CA 91502, (213) 849-1017), is turning new Mustangs into very impressive machines. Reminiscent of Carroll Shelby days, Steve Saleen has been put on a dealer purchase program by Ford.

Saleen begins with a Mustang equipped with selected GT hardware such as the 200 HP H.O. engine, 5-speed transmission, quick ratio steering, GT sport seats and GT instrument cluster which will be replaced with a 170 m.p.h. speedometer and Saleen graphics.

Appearance modifications include a front air dam, side skirts, and a unique rear wing design which was tested and used on Saleen's Trans Am racing Mustang. All of these modifications are matched to body color and trimmed in coordinating stripes.

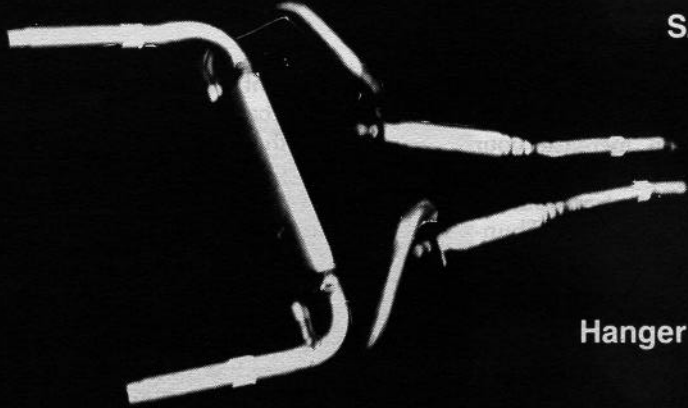
Numerous handling modifications are made which include the use of Koni fully adjustable shocks, Koni's upper tower control yoke, front sway bar modifications, and spring adjustments. The use of Riken 16 x 7 inch wheel and General 225 VR50 performance radials also add to the package.

Some of the "little" details include an Escort radar warning receiver and a Kenwood KRC-6000 sound system. Each car is numbered with the serial number appearing inside the left front headlight cover. So far most of the cars produced have been in the \$16,000 to \$17,000 range.
