The Publishing Committee elected Jerry Gilbert as the new publisher. Gilbert advised that he will be working with the committee and editors to improve the magazine.

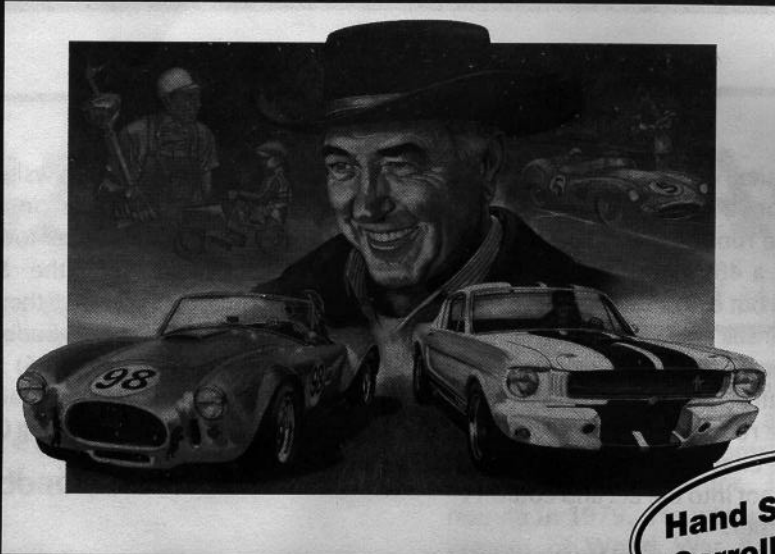

New Business

Problems regarding MCA accessory orders were discussed. It was decided to search for a new vendor to handle accessories. Horace Wood presented a Regional Group application from the **Southeastern North Carolina Regional Mustang Club**. The club's territory is approximately 40 miles. A motion was made and approved accepting this group and their territory.

Bill Dillard advised that some type of claim has been filed with the MCA's insurance company from an incident that apparently occurred in 1991. He will contact the insurance company and advise the Board of the details at a

later date.
