Shorty Brown has been appointed the new Assistant National Head Judge for Modified Mustangs.

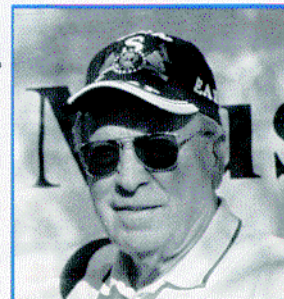
