CLASSIFICATION

ello, my name is Patsy Brown. I will be stepping into the position of Assistant National Head Judge of Classification. I have been actively involved with the Mustang Club of America since the early 1980s, beginning with the Gulf Coast Regional Club in Pensacola, FL, and now with the Gate City Triad Mustang Club in Greensboro, NC.

One of my first jobs with the Gulf Coast Regional Mustang Club was working technical inspection and classification.
