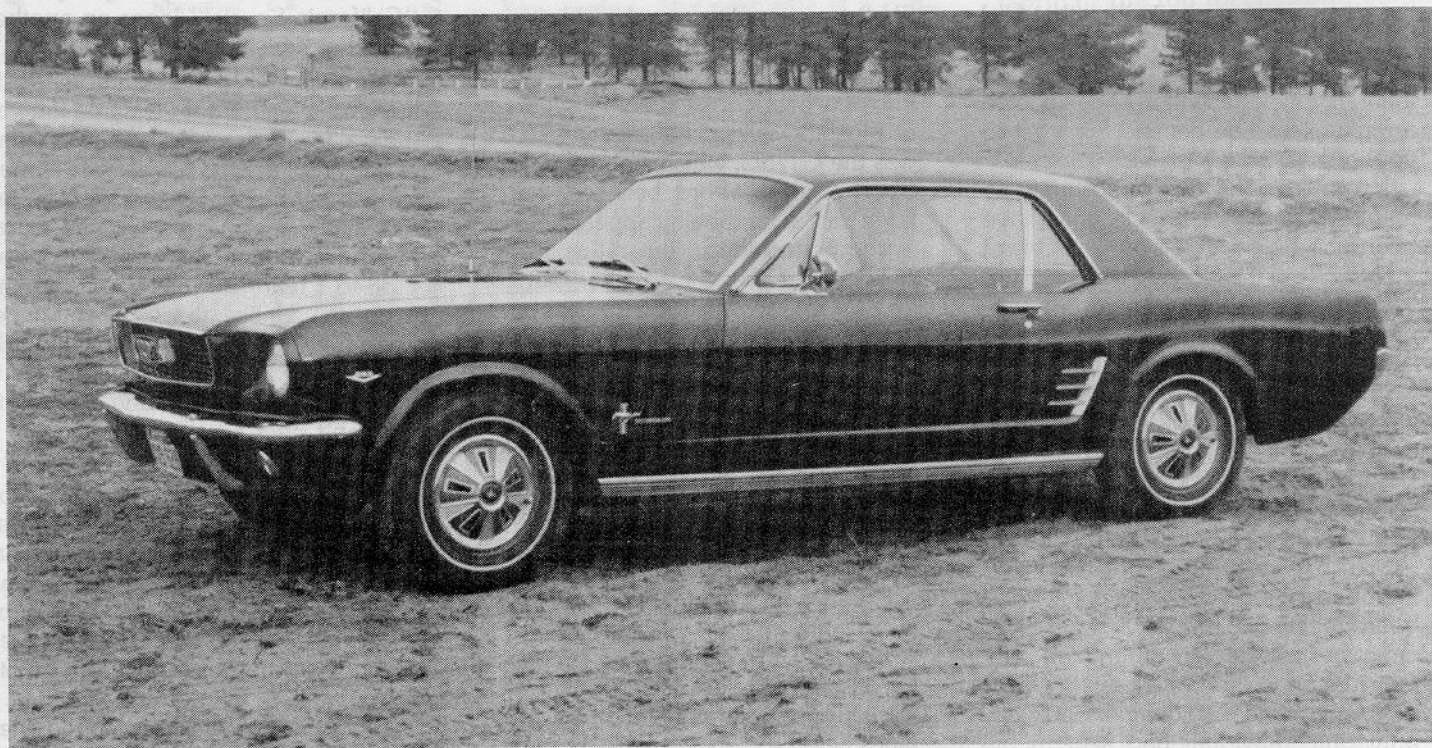


1966 Coupe



My 1966 Mustang hardtop is quite special to me because I am the original owner. I was living in the midwest at the time, training for a new job in the spring of 1966, when I got the Mustang "bug." While in the twin cities, I picked out a Ford dealer whose newspaper ad sounded like he might give me a good "deal." I paid a \$100 down payment on May 9th and then returned on the 27th to pick up the car. It had just arrived (id date is May 24th) and so I was able to watch the dealer preparation process. I left Minneapolis early that

afternoon; before I had had the car 24 hours it had been in five states and driven 700 miles. I have kept a log and made an entry each time I bought gas. When the car had 305 miles on it I paid \$5.09 for 14.9 gallons in Independence, Iowa, and got 19.9 mpg! In the subsequent fourteen years the car has been in 25 states and two Canadian provinces. Interestingly, it hasn't ever been back in Minneapolis and did not return to Minnesota until 1972! Today, it has almost 136,000 miles on it and the engine has never had any work at

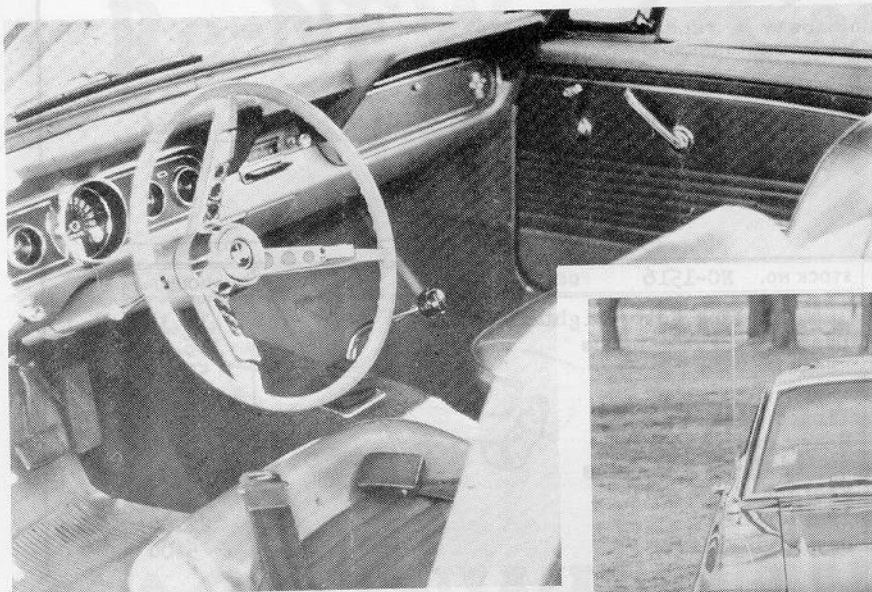
all done on it. I do all the routine work myself.

My car is completely original, Nightmist blue with the 289-2V engine, radio, two-speed wipers, and tinted glass. Market Ford installed the day-night mirror and a trailer hitch along with floor mats during prep. The invoice shows I paid \$2,487.15.

Our Mustang has recently been joined by a 1966 convertible which I hope to restore soon.
